# **ACUTE EFFECTS**

#### **SWALLOWED**

The product is of low acute oral toxicity in the rat.

# **STORAGE AND TRANSPORT**

Storage and Transport Corrosivity Hazards: No corrosivity hazards noted.

Handling & Storage Precautions: Store in the cool place away from heat. Store in a dry area and prevent dust cloud generation. Protect the product from moisture. Take precautionary measures against static discharges. Keep away from food, drink and animal feeding stuffs.

Transport: Not classified as a dangerous good according to the Australian Code for the Transport of Dangerous Goods by Road and Rail.

#### SPILLS AND DISPOSAL

Spillage or Leak Procedures: Absorb with saw-dust. Sweep up and collect for disposal. Place into suitable containers.

Waste Disposal Methods: Follow Avcare guidelines. Incinerate in an approved incinerator, according to government regulations.

### FIRE/EXPLOSION HAZARD

Extinguishing Media: Water fog, fine water spray, foam or dry agent.

Special Fire Fighting Procedures: Firefighters should wear full body protective clothing with self contained breathing apparatus. In case of fire, prevent by any means possible spillage from entering drains or water courses.

Reactivity Hazards: No hazards are expected if the material is handled, stored and used according to instructions and government regulations.

## **OTHER INFORMATION**

#### PROTECTION OF CROPS, NATIVE AND OTHER NON-TARGET PLANTS

In the case of crop failure, when the land must be replanted to another crop within 4 to 8 weeks after treatment, the following tolerant crops may be planted – potatoes, onion, maize, sorghum, safflower and sunflower. The following susceptible crops should not be planted until 4 to 8 weeks have elapsed following treatment with PYRAMIN – cucumbers, melons, tomatoes, snap beans, lima beans, lettuce, cabbages, grapes, carrots and spinach. Prior to replanting crops other than those already mentioned, consult your local BASF representative.

Do NOT apply under weather conditions or from spraying equipment that may cause spray to drift onto nearby susceptible plants/crops, cropping lands or pastures.
