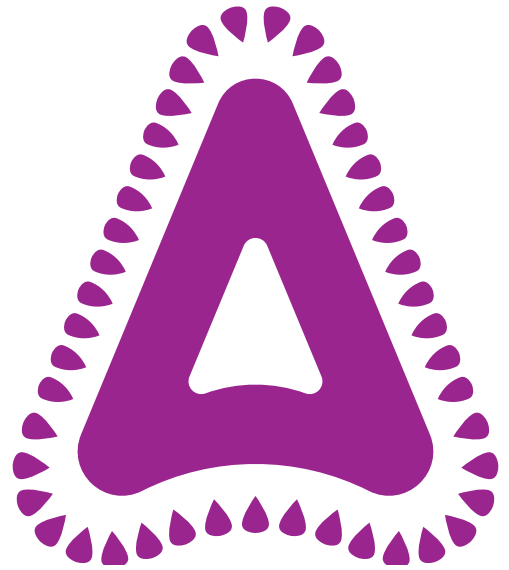

GENERAL INSTRUCTIONS

Scatter pellets using an appropriate applicator. The best time to apply is immediately after rain, or during humid overcast weather when slugs and snails are most active. The pellets eventually decompose leaving no harmful residue. Use regularly to control re-infestation.

PRECAUTION

DO NOT apply to edible plant parts.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

PROTECTION OF DOMESTIC ANIMALS AND LIVESTOCK

Keep away from animals, poultry, ducks and domestic pets as accidental poisoning may be fatal. Dogs and other animals find this bait attractive and it may kill them. If pets or livestock are poisoned contact a veterinary surgeon.

STORAGE AND DISPOSAL

Store in the closed, original container in a dry, cool, well-ventilated area, out of direct sunlight. Store in a locked room or place away from children, animals, food, feedstuffs, seed and fertilisers. Shake empty into applicator. DO NOT dispose of unused product on-site. Break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.
