#### MIXING

Add the required amount of product directly to the spray tank and mix well.

#### COMPATIBILITY

AURORA TURF is compatible with chlorothalonil.

resistance management AURORA TURF is a Group C fungicide. Some naturally occurring individual fungi resistant to AURORA TURF or any other Group C fungicides may exist through normal genetic variability in any fungal population. The resistant individuals can eventually dominate the fungi population if these fungicides are used repeatedly. The resistant fungi will not be controlled by AURORA TURF or other Group C fungicides, thus resulting in a reduction in efficacy and possible yield loss.
