Spray Preparation

Chemag EDGE 500 WG Herbicide is a Wettable Granule formulation to be blended with water and applied as a spray.

- Partly (30%) fill the boomspray-tank with water.
- Put the required amount of Chemag EDGE 500 WG Herbicide for the area to be sprayed into water containers.
- Add this correct amount of pre-mixed Chemag EDGE 500 WG Herbicide into the boomspray-tank with the agitation system operating.
- Fill up to the correct volume with water. The mixture must be kept in suspension at all times by continuous agitation.
- Tank-mixtures should be tested for physical compatibility and efficacy before use.

DO NOT mix with MCPA. If tank mixing, Chemag EDGE 500 WG Herbicide must be in suspension before adding other herbicides, insecticides or surfactants.

Wash sprayer thoroughly after use.
