<b>Recommended Use</b>	For the control of broadleaved weeds in fallow before direct drilling or sowing of cereals and pastures; and in cereal crops, pastures, sugar cane, peanuts and non-agricultural areas as per the Directions of Use table on the label.
<b>Other Information</b>	This is a PHENOXY HERBICIDE that can cause severe damage to susceptible crops such as cotton, grapes, tomatoes, oilseed crops and ornamentals. This MSDS describes, to the best of our knowledge, the properties of the concentrated product. The physical properties and some of the assessments do not apply to the properties of the product once it has been diluted for application. Acute health effects of the diluted product are likely to be much less severe.

<b>Ingestion</b>	<p>Remove affected person to fresh air until recovered.</p> <p>If poisoning occurs, contact a doctor or the Poisons Information Centre (Australia) on 13 11 26.</p> <p>Give a glass of water.</p> <p>If swallowed do NOT induce vomiting; seek medical advice immediately and show this container or label or contact the Poisons Information Centre on 13 11 26 (Aust). Make every effort to prevent vomit from entering the lungs by careful placement of the patient.</p> <p>The above first aid instructions are mandated by the Commonwealth Department of Health and Ageing via the National Drugs and Poisons Schedule. **Other Information** Equipment that has been used for this chemical should not be used for the application of other materials to sensitive plants, unless it has been well washed out with hot soapy water or 1% solution of ammonia, followed by several clear water rinses.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**National Exposure Standards** No exposure standard for this product has been set, however, an exposure standard has been set for 2,4-D acid at 10 mg/m<sup>3</sup>.

**Engineering Controls** Natural ventilation is sufficient when handling concentrate and preparing spray solution.

**Respiratory Protection** Do not inhale spray mist.

**Personal Protective Equipment** When preparing spray, wear PVC or rubber apron, elbow length PVC gloves and face shield.  
When using the prepared spray, wear face shield.

**Hygiene Measures** After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water.  
After each day's use, wash contaminated clothing and safety equipment.

**Requirements Concerning Special Training** Check State or Territory regulations that require people who use pesticides in their job or business to have training in the application of the materials.

## 9. PHYSICAL AND CHEMICAL PROPERTIES

**Appearance** Clear, red-brown liquid with ammoniacal odour.

## 10. STABILITY AND REACTIVITY

**Chemical Stability** Stable under normal conditions.

**Incompatible Materials** Reaction of the concentrate or spray mix with acids will precipitate solid 2,4-D acid and largely de-activate the product and cause blockages in spray equipment.  
The addition of a strong alkali such as caustic soda will cause release of dimethylamine vapour.  
Dimethylamine is moderately toxic, LD50 (oral, rat) is 700 mg/kg and a TLV of 10 ppm (TWA) has been set.

**Hazardous Reactions** Keep away from strong oxidising agents.

**Hazardous Polymerization** Hazardous polymerisation is not possible.

## 11. TOXICOLOGICAL INFORMATION

**Toxicology Information** No harmful effects are expected if the precautions on the label and this MSDS are followed.

**Inhalation** The components of the product are of low volatility and no adverse effects are expected from handling the concentrate.

<b>Ingestion</b>	The concentrate is considered harmful by inhalation by Worksafe Australia. A moderate hazard exists from inhalation of spray and care should be taken to avoid inhalation of spray mists. Not a likely route of exposure. Amounts swallowed incidental to normal handling procedures and use are not expected to cause injury. However, swallowing of large amounts may cause injury. Ingestion of the product in relatively large amounts can result in headache, nausea, lethargy, motor weakness and incoordination.
<b>Skin</b>	Prolonged contact with the concentrate may cause irritation. Prolonged contact of the concentrate with skin will result in absorption of some 2,4-D which can be harmful.
<b>Eye</b>	The concentrate will cause irritation of the eyes. Prolonged contact with the concentrate may cause damage to the eye.
<b>Chronic Effects</b>	Chronic Overexposure: Repeated absorption of relatively large amounts of 2,4-D presents a risk to the liver and kidneys.
<b>Carcinogenicity</b>	The weight of the evidence is that 2,4-D is not carcinogenic.
<b>Acute Toxicity - Oral</b>	LD50 (rat) 699 mg/kg for 2,4-dichlorophenoxyacetic acid LD50 (rat) 700 mg/kg for dimethylamine LD50 (rat) 710 mg/kg for diethanolamine
<b>Acute Toxicity - Dermal</b>	LD50 (rabbit) >2000 mg/kg
<b>Acute Toxicity - Inhalation</b>	LC50 (rat) (4hr) >1.79 mg/l
<b>Skin Irritation</b>	Not a skin irritant.
<b>Skin Sensitisation</b>	Product is not a skin sensitiser.
<b>Other Information</b>	The Australian Acceptable Daily Intake (ADI) for 2,4-D for a human is 0.01 mg/kg/day, set for the public for daily, lifetime exposure. This is based on the NOEL of 1 mg/kg/day, the level determined to show no effects during long term exposure for the most sensitive indicators and the most sensitive species. (Ref: Comm. Dept. of Health and Ageing Office of Chemical Safety and Environmental Health, 'ADI List', March 2010). In trials using 2,4-D as a drug, studies on volunteers have shown that doses of between 5 and 36 mg/kg body weight do not cause any acute toxic effects. Formulated 2,4-D products can be absorbed by ingestion, inhalation (spray mist) and through the skin. Studies of users (sprayers) has shown that absorption through the skin is the most common route. When used with good agricultural spraying practice and good personal hygiene, absorption of 2,4-D is very low.

## 12. ECOLOGICAL INFORMATION

<b>Persistence / Degradability</b>	Half life in soil is typically 7 days. Loss from soil is principally by microbial degradation.
<b>Mobility</b>	Rapid degradation in soil prevents significant downward movement under normal conditions.
<b>Known Harmful Effects on the Environment</b>	2,4-D amine products do not appear to pose any threat to birds. 2,4-D amine products do not appear to pose any threat to fish or other aquatic organisms other than in very high concentrations.
<b>Environ. Protection</b>	Spray drift can cause damage, read the label for more information.
<b>Acute Toxicity - Fish</b>	Not toxic to fish. LC50 (96 hr) for (rainbow trout) is ~100 mg/l.
<b>Acute Toxicity - Daphnia</b>	LC50 (48hr) for 2,4-D amines is 184 mg/l.
<b>Acute Toxicity - Other Organisms</b>	Birds: Not toxic to birds. LD50 for (mallard ducks) is >1000 mg/kg Bees: Not toxic to bees. LD50 104.5 µg/bee.
<b>Sewage Treatment</b>	Not inhibitory in sewage system, 2,4-D is rapidly biodegraded.

## 13. DISPOSAL CONSIDERATIONS

collections of unwanted chemicals (ChemClear®).  
 Do not use this container for any other purpose.
