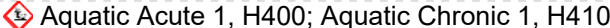

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal. Clean spill area with water and detergent. For complete decontamination spread hydrated lime over the affected area.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Use only outdoors or in a well-ventilated area.

Do not burn empty containers.

Food, beverages and tobacco products should not be stored or consumed where this material is in use.

Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

The Australian ADI for pyriproxyfen for a human is 0.07 mg/kg/day, set for the public for daily, lifetime exposure. This is based on the NOAEL of 7 mg/kg/day.
