Section 2 - Hazards Identification

Statement of Hazardous Nature

This product is classified as: Hazardous according to the criteria of NOHSC Australia.

Not a Dangerous Good according to the Australian Dangerous Goods (ADG) Code.

Emergency Overview

Physical Description & colour: White to beige liquid.

Odour: Mild, characteristic odour.

Major Health Hazards: no significant risk factors have been found for this product.

Potential Health Effects

Signs and Symptoms of Poisoning: Although no account of human poisoning was found in the literature, signs and symptoms of poisoning would be expected to be similar to nicotinic signs and symptoms, including fatigue, twitching, cramps, and muscle weakness including the muscles necessary for breathing.

Inhalation

Short term exposure: Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

Long Term exposure: No data for health effects associated with long term inhalation.

Skin Contact:

Short term exposure: Available data indicates that this product is not harmful. It should present no hazards in normal use. However product may be irritating, but is unlikely to cause anything more than mild transient discomfort.

Long Term exposure: No data for health effects associated with long term skin exposure.

Eye Contact:

Short term exposure: Exposure via eyes is considered to be unlikely. This product may be irritating to eyes, but is unlikely to cause anything more than mild transient discomfort.

Long Term exposure: No data for health effects associated with long term eye exposure.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:

Inhalation: First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

Skin Contact: Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 5 minutes or until chemical is removed.

Eye Contact: No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

Ingestion: If product is swallowed or gets in mouth, wash mouth with water and give some water to drink. If symptoms develop, or if in doubt contact a Poisons Information Centre or a doctor.

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards: There is no risk of an explosion from this product under normal circumstances if it is involved in a fire.

Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned below (section 8).

Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. If spill is too large or if absorbent material is not available, try to create a dike to stop material spreading or going into drains or waterways. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Recycle containers wherever possible after careful cleaning. Refer to product label for specific instructions. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Full details regarding disposal of used containers, spillage and unused material may be found on the label. If there is any conflict between this MSDS and the label, instructions on the label prevail. Ensure legality of disposal by consulting regulations prior to disposal. Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this MSDS for details of personal protective measures, and make sure that those measures are followed.

Section 11 - Toxicological Information

Imidacloprid is harmful. The LD₅₀ is 450 mg/kg body weight in rats, and 131 mg/kg in mice. The 24-hour dermal LD₅₀ in rats is >5,000 mg/kg. It is considered non-irritating to eyes and skin (rabbits), and non-sensitizing to skin (guinea pigs). Some granular formulations may contain clays as inert ingredients that may act as eye irritants. The LC₅₀ is > 69 mg/m³ air in the form of an aerosol, and >5323 mg/m³ air in the form of dust. These values represent the maximum attainable airborne concentrations.

No ingredient mentioned in the List of Designated Hazardous Substances is present in this product at hazardous concentrations.

Section 12 - Ecological Information

Imidacloprid is highly toxic to bees if used as a foliar application, especially during flowering, but is not considered a hazard to bees when used as a seed treatment

Breakdown of Chemical in Soil and Groundwater: The half-life of Imidacloprid in soil is 48-190 days, depending on the amount of ground cover (it breaks down faster in soils with plant ground cover than in fallow soils). Organic material aging may also affect the breakdown rate of Imidacloprid. Plots treated with cow manure and allowed to age before sowing showed longer persistence of Imidacloprid in soils than in plots where the manure was more recently applied, and not allowed to age. Imidacloprid is degraded stepwise to the primary metabolite 6-chloronicotinic acid, which eventually breaks down into carbon dioxide. There is generally not a high risk of groundwater contamination with Imidacloprid if used as directed. The chemical is moderately soluble, and has moderate binding affinity to organic materials in soils. However, there is a potential for the compound to move through sensitive soil types including porous, gravelly, or cobbly soils, depending on irrigation practices.

Breakdown of Chemical in Surface Water: The half-life in water is much greater than 31 days at pH 5, 7 and 9. No other information was found.

Breakdown of Chemical in Vegetation: Imidacloprid penetrates the plant, and moves from the stem to the tips of the plant. It has been tested in a variety of application and crop types, and is metabolized following the same pathways. The most important steps were loss of the nitro group, hydroxylation at the imidazolidine ring, hydrolysis to 6-chloronicotinic acid and formation of conjugated compounds.

Section 13 - Disposal Considerations

Disposal: Instructions concerning the disposal of this product and its containers are given on the product label. These should be carefully followed.

Section 14 - Transport Information

ADG Code: This product is not classified as a Dangerous Good. No special transport conditions are necessary unless required by other regulations.

Section 15 - Regulatory Information

AICS: All of the significant ingredients in this formulation are to be found in the public AICS Database. The following ingredients: Imidacloprid, are mentioned in the SUSDP.
